# **Update Underway for NACUSAC U**



<u>NACUSAC University</u> curriculum is being updated to more accurately reflect today's supervisory committee duties and responsibilities. As credit union regulations have become more complex over the last decade so has the committee's oversight role. The curriculum will be expanded to ensure that committee members are adequately prepared to fulfill their oversight duties when they graduate from NACUSAC U.

It's anticipated that the update will be rolled out in June 2023. Students who are enrolled and completing courses prior to June 2023 will be grandfathered into the pre-update graduation requirements.
