**To be considered for nomination, the following documents must be submitted:**

- A letter/email from the nominee indicating their intent to run and willingness to fulfill the role and responsibilities of a NACUSAC Board member
- A letter of support from the nominee's credit union indicating their pledge to provide financial support for the nominee to attend and participate in board meetings
- A brief biography of the nominee and .jpg headshot photo (if available)

- Nominees must also either be enrolled in or a graduate of NACUSAC University
